# Family Farm Business Succession Planning Workshops

Growing Forward 2 (a provincial-territorial initiative)
BCGA and BCFGA in cooperation with the BC Ministry of Agriculture

For most farm families, planning for succession is the toughest and most critical challenge they face. Yet succession planning can also be a great opportunity to maximize opportunities and once the plan is finalized, there is the satisfaction of knowing that the best effort has been made to meet the needs, goals and wishes of everyone involved.

Succession Planning takes more than a few days, in many cases it may take several years to finalize. There is a lot of discussion and information gathering to be done and having some tools and insight into the process will help. To assist you in tackling Succession Planning, we have designed a workshop that will provide a neutral environment to explore the "need to do" list and provide feedback (consulting) from a lawyer and accountant.

At the end of the workshops, participants will have an understanding of a process that will assist them with information gathering, goal setting as well as information on tax tools and issues, business arrangements, life interests, security, methods of owning property, will planning and life insurance.

## Agriculture and Agri-Food Canada



Agriculture & Agri-food Canada (AAFC) and the BC Ministry of Agriculture have announced the launch of the Canada – BC Agri-Innovation Program. This program is a \$3 million, two-year commitment through the Growing Forward 2 agreement. It's a cost-shared program that will allow industry to access funding to support the acceleration of innovation. The late-stage research projects must lead to commercialisation and/or adoption of innovative products, technologies, and practices. For example, projects that could be considered include the following:

- · Advancements in plant, animal, and food science
- Energy and waste management
- New product development and commercialisation
- Improvements in soil, water, and air quality
- Climate change adaptation

To be eligible, applicants must be appropriately registered, licensed and/or certified to conduct business in BC. Eligible applicants may include the following:

- BC agri-food producers and processors
- Industry associations and organisations
- Retail and food-service businesses
- Input, technology, and support service providers
- · Academic institutions and/or other organisations and private sector businesses
- Regional districts and local governments
